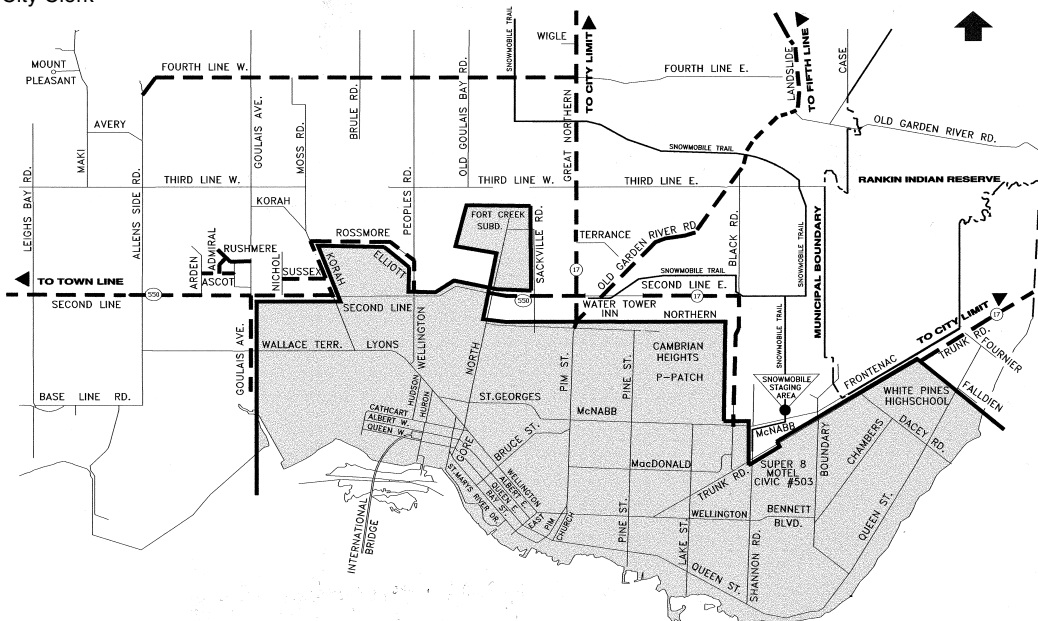


BY-LAW 69-6 AS AMENDED REGULATING THE OPERATION OF SNOWMOBILES INSIDE THE CITY LIMITS

The following is a summary only of the snowmobiling by-law and should not be relied upon in determining snowmobiling rights and restrictions in the City. By-law 69-6 as amended regulates the operation of motorized snow vehicles in the City of Sault Ste. Marie. Snowmobiling is permitted only in certain areas of the City of Sault Ste. Marie as outlined on the map below. In addition, where snowmobiling is permitted the following restrictions apply: ●No snowmobiling on any sidewalk, ●No snowmobiling between 11:00 p.m. and 8:00 a.m. Other restrictions or exemptions may apply. A complete copy of the snowmobiling by-law can be obtained from the City Clerk's Office, 4 th Floor, Civic Centre.
